Saddle Consignment Terms & Conditions

1. This Consignment & Trade-In Agreement (agreement) is between the rightful owner (owner) of the item (item) as indicated on the reverse side of this form, and the consignee, Dutchess Bridle & Saddle, LLC (DBS).
2. *The consignment fee is 20% of the asking price. This fee is non-negotiable and subject to change without notice.*
3. Owner represents that they have legal title to the item, free and clear of any liens, interests or encumbrances by any other party and holds DBS harmless from any action pertaining to the item.
4. DBS shall offer the item for sale on behalf of the owner. The selling price shall be determined by the owner and negotiating power discussed with DBS. An approximate price less consignment, trade-in or other applicable fees have been indicated on the front of this agreement.
5. Owner agrees to an initial consignment period of six (6) months. If the item has not sold in that time, the owner will be contacted to re-consign for an additional 3 months or return the item. *The owner will be responsible for return shipping fees where applicable.*
6. DBS makes no guarantee or warranty as to when and if the item will actually be sold. *Saddles will not remain on consignment for more than 9 months.*
7. Sending out the item for potential buyers to try has been discussed and noted on this contract whether or not the client has agreed to allow it.
8. If the owner is able to sell their item while it is on consignment with DBS, DBS will ship the item back to the owner or the purchaser of the item. The owner is responsible for paying all shipping costs.
9. Upon final sale of the item, DBS will pay the owner the selling price less any consignment percentage or other applicable fees. Payment shall be made via company check within 14 business days of the completion of the final sale.
10. DBS will take every reasonable precaution to insure the safety of the item. *Items are sold as is.* Any additional repair work needed to the item to make it saleable will be paid for **before** item is made available for sale. All repairs are paid for up front **before** item is made available for sale. Items will not be accepted for consignment which requires repairs beyond a reasonable limit.
11. DBS has made a note of all marks, scratches, dings and other cosmetic markings on the item and can include a photographed record of them with this signed agreement.
12. Saddles needing to be cleaned and conditioned will carry an extra charge of \$35.
13. The risk of loss or damage to the item shall be borne by DBS. DBS assumes limited liability for such risks.
14. The item can be requested to be returned to the client at any time. The owner will be responsible for return shipping fees.
15. DBS reserves the right to terminate this agreement at any time for any reason.
16. In the event of any disagreement over the terms of this agreement, New York law shall govern. The State of New York, County of Orange, shall have exclusive jurisdiction, and the owner agrees to bind themselves to the jurisdiction of said courts. If DBS sues the owner to enforce its rights under this agreement, owner shall be liable for all costs, disbursements, and attorney's fees incurred by DBS.
